- Proposed a letter be written by Geyserville Planning Committee for an endorsement, requesting a revised Cal Fire map that designates Geyserville, within a high Fire Hazard Severity Zone.
- The Fire Maps are going to change, which has the potential to be more expensive for insurance in the future, depending upon which area you're living in; west of the Russian River and East of the Russian River, depending on fire zones.
- It was discussed that it will be the East of the River who will be the most impacted by fires and escalating insurance rates; that being vineyards and mountainside homes. The westside is not in the same imminent danger, being westside of Russian River Valley, downtown, and some local homes.
- Handouts were available for those concerned.

- O Slide Presentation. Going through design production, just making wine at this winery. Going from 250,00 cases of wine to 700,000 cases of wine. Discussions for potential construction renderings are forthcoming. A full explanation of the growth would be to create one more building, the size of what currently exists, storage tanks, primarily. No more winemaking would be happening at the new building, relocating of tanks, increasing employees, same size of buildings comparable. Above the casino, so it's pretty much hidden.
- o Use permit must be approved.
- o Monday through Friday usage.
- The community was satisfied that the proposed construction was accepted by those present.
- o Daisy Damskey called for more neutral colors, so it is still pleasing from the roads.
